1. Cleaning products

EU-Biocide Regulation

The EU Regulation (EC) No 528/2012, also referred to as EU Biocidal Products Regulation, is a regulation that governs the manufacture, labelling, market circulation and use of biocidal products, which serve to protect people, animals, materials or products against hazardous organisms such as parasites or bacteria.

The proposal was adopted on 22 May 2012 by the European Parliament and the European Council in Brussels and entered into force on 17 July 2012.

EU-CLP Regulation

Regulation (EC) No 1272/2008 including No 2024/2865/EU on the classification, labelling and packaging of substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006. Application of GHS in Europe

EU-Regulation on Detergents

Regulation (EC) No 648/2004 on detergents

Governs the requirements for the aerobic, ultimate biodegradability of surfactants in detergents, exemptions for the market circulation of surfactants in detergents where requirements concerning the ultimate aerobic biodegradability, labelling regulations for detergents and information duties of the manufacturer are not satisfied

EU-REACH

Regulation (EC) No 1907/2006 on the Registration, Evaluation, Authorisation and Restriction of Chemicals in the EU is complemented by CLP by ensuring that the hazards posed by chemicals are correctly classified and communicated

EU-Ecolabel

Regulation (EC) No 66/2010 on the EU ecolabel

UN-GHS

Globally Harmonised System of Classification and Labelling of Chemicals (GHS).
United Nations – UN system for the globally standardised classification and labelling of chemical substances and products

German Waste Water Ordinance Ordinance on requirements for the discharge of waste water into water bodies (Abwasserverordnung – AbwV) - concretizes the analysis and measurement procedure

D- German Detergents and Cleaning Products Act

The German Cleaning Agents and Detergents Act (WRMG), full title "Act on the environmental compatibility of cleaning agents and detergents", governs the environmentally sustainable composition of cleaning agents and detergents on the German market

Nordic Swan

Nordic ecolabel, also referred to as Nordic Swan or in Scandinavia simply as “The Swan“, is an ecolabel of the Nordic Council of Ministers. It was enacted in 1989 and encompasses 63 product groups. It is the official ecolabel of the Nordic countries. It is a Type-I Eco-label (ISO 14024), as a statement about the environmental sustainability of products compared with competitor products is issued by independent third parties

Regulation (EC) No 2023/2006 on good manufacturing practice for materials and articles intended to come into contact with food

EU-Ceramics

Directive 84/500/EEC on the approximation of the laws of the Member States relating to ceramic articles intended to come into contact with foodstuffs. The directive defines maximum levels of cadmium and lead that may be transferred from ceramic goods to the food that they come into contact with

Regulation (EC) No 10/2011 on plastic materials and articles intended to come into contact with foodstuffs

EU-Single-Use Plastics Directive

Directive (EU) 2019/904 on the reduction of the impact of certain plastic products on the environment

Regulation (EC) No 1935/2004 on materials and articles intended to come into contact with food. The regulation also governs the supply chain and the purity of the plastics

EU-Metals and Alloys

Resolution **CM/Res(2024)9** on metals and alloys used in food contact materials. The technical guideline's recommendation includes specific release limits (SRLs) for metal ions that are released from materials in contact with foodstuffs and their analysis methods



D-German Food and Feed Code

The German Food and Feed Code (LFGB) describes the handling of consumer goods. It encompasses all production and processing stages along the entire food chain and applies to animal feed and cosmetics, as well as food and consumer goods. Food safety is of paramount importance. The manufacturer, retailer or distributor must guarantee satisfactory quality and traceability of the goods.

D-Bedarfsgegenstände

The German Consumer Goods Ordinance (BedGgstV) stipulates which materials are permitted for consumer goods and food packaging, and the permitted level of contamination on the body and / or from the packaging in the food.

DIN EN 631-1 „Gastro-Norm“

Materials and articles in contact with foodstuffs; catering containers; Part 1: Dimensions of containers. Gastronorm is a globally harmonised system of measurement, whereby the use of standard sizes enables a simple exchange of catering containers and is used in the catering industry and in commercial kitchens.

Permissible limits for the release of lead and cadmium from articles intended for use in contact with food.
